Tracy McPherson moderated this monthly call. Summaries of agenda items are listed below:

Track A and Track B Updates

The schools who are participating in Track A and Track B have started planning and/or implementing their programs. There are eleven programs participating in the Track A evaluation. These schools were randomly assigned to an implementation or delayed control group. They are only piloting the Kognito online simulation at this point and will integrate the curriculum later after the piloting phase is over. The implementation group has begun pre-tests and piloting of the program for 3 weeks. Once their period is over, students will take a post-test and then the delayed control group will have access. At first glance, we have a large sample size for those who are doing implementation currently which shows that the participating schools have taken a great initiative to reach out to get students involved. The timeframe for Track A is January 2016 through May 2016.

There are twelve schools who are participating in the full implementation Track B from January 2016 through September 2017. Danielle Noriega has been working closely with participating schools completing check-in calls with them to gauge progress. Each school will also turn in quarterly reports to track number of students reached, courses that the curriculum has been placed, and activities and objectives for the quarter. Currently schools are in the early stages of implementation. Some have used the simulation and curriculum to train their faculty, others are piloting it in a single course. Based on proposals, the plan for where the simulation will fit varies however most have it as a required component of the coursework either through classroom practice or homework assignments. Steering Committee members encouraged NORC to consider the time that each of the schools give the students with the simulation, previous work with

adolescents as well as the level of SBIRT knowledge that the students have before the simulation. The context in which the program is implemented can affect differences in the evaluation.

NORC would like to do another request for application to allow for more evaluation. Learning Collaborative members have expressed interest in another round of funding. Several have also requested including the current workforce in the population to train. NORC is planning internally for a second round of funding and will provide updates when available.

Adolescent SBIRT Curriculum

The curriculum including the learner's guide is now available. An announcement was sent to the Steering Committee via email on Monday, January 25th. There is a tab on the project website dedicated to the curriculum located at http://sbirt.webs.com/curriculum. The page includes a list of suggested readings with the links of how to access them, order forms to request electronic and hardcopies of the learner's guide, and an informational flyer on the *SBI with Adolescents* simulation. Joan Stanley requested that the informational flyer for the simulation be updated with more information on who to contact to license the program. Currently it is not clear on how to get more information for those who are interested in the simulation. Misti Storie is assisting NORC with the website and will make the requested changes.

NORC attached a flyer with a link to the simulation program to the meeting email reminder. This link is for Steering Committee members only, please do not share the link with non-members. Thus far, the feedback on the program has been positive. On the February 9th Learning Collaborative call, several participants noted that their students like the program and found it easy to use. Steering Committee members are encouraged to use the simulation and share their feedback with NORC and Kognito.
